Rhode Islanders of all ages who are Blind or Visually Impaired. This includes those individuals with an acuity of 20/60 or less in the better eye with correction, or fields of twenty degrees or less in the better eye.

Services are provided **STATEWIDE** in your community—at home, schools, and worksites.
